

# DISNEY STORE "I HEART MINNIE" GIFT SET SWEEPSTAKES

## OFFICIAL RULES

### NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN, NOR WILL A PURCHASE IMPROVE ONE'S CHANCES OF WINNING

**1. SPONSOR:** Disney Shopping, Inc., 443 S. Raymond Ave., Pasadena, CA 91105, is solely responsible for all aspects of this sweepstakes ("Sweepstakes").

**2. ENTRY:** During the period beginning at 12:01 A.M. PDT, February 10, 2012, and ending at 11:59:59 P.M. **3. LIMITATIONS:** All Entries must be received by 11:59:59 P.M., February 12, 2012. Only one Entry per person/email address ("Address"), regardless of whether one person has more than one Address or more than one person use the same Address. In event of a dispute regarding the identity of the person submitting an Entry, the Entry will be deemed to be submitted by the person in whose name the Address is registered. Entries by any method other than set forth above in Section 2 are void. Any use of automated or programmed methods of effecting Entry is prohibited. Open only to persons who are 18 or older upon entering and legal residents of, and physically located within, the 50 states or D.C. (collectively, "Territory"). Employees of the Sponsor; its parent, subsidiary, and affiliated companies; the advertising, promotional and fulfillment agencies of each of them (individually and collectively, "Entities"); the members of their households and of their immediate families, are all ineligible to participate in the Sweepstakes. Each of such potential Entries will be disqualified and any attempt by a person to use multiple email accounts to register more than once may result in disqualification at Sponsor's sole discretion.
