

**Disney Store's 2013 Frozen RT2WIN on Twitter
OFFICIAL RULES**

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN, NOR WILL A PURCHASE IMPROVE ONE'S CHANCES OF WINNING.

1. SPONSOR: Disney Store USA, LLC, 443 S. Raymond Avenue, Pasadena, CA 91105 is solely responsible for all aspects of this Sweepstakes ("Sweepstakes").

2. ENTRY: Sponsor invites you to enter during the period commencing at 11:00 A.M., November 20, 2013 and ending at 10:59:59 A.M., November 21, 2013 ("Entry Period"), by submitting an entry on Sponsor's Twitter page by "following" Disney Store on Twitter (<http://Twitter.com/DisneyStore>) and by re-tweeting any of the Disney Store tweets including the Link "<http://bit.ly/17LQzLJ>" made during the Entry Period ("Entry"). Normal Internet access and usage charges imposed by your online service will apply. It is your sole responsibility to notify the Sponsor in writing if you change your Twitter account ("Account"). For purposes of these Official Rules ("Rules"), all times and days are Pacific Time.

3. LIMITATIONS: Each Entry must be received during the Entry Period. You may enter this Sweepstakes no more than once per person per Account (regardless of whether one person has more than one Account or more than one person use the same Account). In event of a dispute regarding the identity of the person submitting an Entry, the Entry will be deemed to be submitted by the person in whose name the Account is registered by Twitter. Entries by any method other than set forth above in Section 2 are void. Any use of automated or programmed methods of effecting Entry is prohibited. Open only to persons 13 or older who are legal residents of, and physically located within, the 50 states, D.C., or Canada (excluding Quebec) (collectively, "Territory") and not employees of Sponsor, its parent, subsidiary, affiliate or agency (individually and collectively, "Entities"), nor members of their households or immediate families. Neither the Entities nor any of their officers, directors, shareholders, employees, agents, or representatives (individually and collectively, "Releasees") are responsible for Entries from persons residing, or physically located, outside the Territory; or Entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, irregular in any way, late, lost, misrouted, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Rules; or for lost, interrupted or unavailable network, server or other connections; miscommunications; failed phone, computer hardware or software or telephone transmissions; technical failures; unauthorized human intervention; traffic congestion; garbled or jumbled transmissions; undeliverable emails resulting from any form of active or passive email filtering; insufficient space in your email account to receive email; or other errors of any kind, whether due to electronic, human, mechanical, printing, production or technical errors or other causes; even if caused by the negligence of any of the Releasees. Each of such potential Entries will be disqualified. Void where prohibited or restricted by law and subject to all applicable federal, state, provincial, local and municipal laws and regulations.

4. PRIZE: ONE (1) GRAND PRIZE: One (1) "Frozen Prize Pack" composed of one of each of the following elements: **(1)** Anna Classic Doll – 12" (approximate retail value ["ARV"]: \$16.95); **(2)** Kristoff Classic Doll – 12" (\$16.95); **(3)** Anna Costume Accessories Set for Girls (\$19.95); **(4)** Frozen Tri-Fold Journal (\$12.95); **(5)** Frozen Finger Puppet Set (\$14.95) and **(6)** Olaf Plush – 9" (\$14.95). Total ARV of Grand Prize: \$96.70. Prize is not redeemable for cash or transferable. No substitution allowed except, at Sponsor's sole discretion, a prize of equal or greater value may be substituted. The prize will be awarded provided it is validly claimed by December 1, 2013, after which no alternate winner will be selected, nor unclaimed prize awarded.

5. PROCEDURES: Entries must be received during the Entry Period. On or about November 21, 2013, in a random drawing, Sponsor will select the potential winner from among all those eligible Entries received. Odds of winning depend on the total number of eligible Entries received.

6. WINNER: The potential winner will be sent a Direct Message by Sponsor within 24 hours after the drawing. In order to be declared a winner, you must meet the eligibility requirements in Section 3 above and respond to Sponsor's Direct Message by sending your name, email address, shipping address and phone number to Disney Store at the email address provided by the Sponsor, (subject should be the words provided in Sponsor's tweet) within 24 hours after Sponsor sent you the Direct Message. All legal responsibilities under the Rules of a minor (as defined by state or province of primary residence) will be assumed by a parent/legal guardian. At the sole discretion of the Sponsor, disqualification, forfeiture and the selection of an alternate winner may result from any of the following: **[1]** potential winner's failure to respond with the required information to the notification within twenty-four (24) hours after its transmission; **[2]** the
